## Objectives

- Demonstrate the improvement and quality of Charolais cattle in Kentucky and surrounding states.
- Provide a consistent outlet for breeders of quality Charolais cattle where their cattle can be grouped in numbers sufficient to garner prices that reward them for producing quality cattle.
- Increased consistency and predictability for the buyers of our cattle.
- A higher quality product for our consumers.



## Sale Management

### Consignment

- Cattle must be tagged with a Kentucky Certified Charolais tag, available by calling the Kentucky Beef Network.
- Cattle must arrive by 2 p.m., May 15th accompanied by a completed and signed Health and Management Form.

### Grading & Sorting

- Consignors must be able to verify Charolais influence.
- All cattle will be graded by a KY Dept. of Agriculture Ag Grader
- Cattle will be sorted into 100 pound increment pens by three breed sorts; Charolais, Smokes, Yellow and sex.
- Sale management will review the sorted and graded cattle and may combine pens to make load lots.

### Commission & Fees

- The Charolais Influenced Feeder Calf Alliance will collect \$4/head to support the advertising and promotion of Charolais cattle in Kentucky, this will be deducted from your check.
- The cost of tags ordered is \$2/tag and will be deducted from your check by the Charolais Influenced Feeder Calf Alliance
- Blue Grass will deduct the following fees from your check:
  1. Commission fee of \$20/head
  2. Beef Checkoff \$2/head
  3. Insurance
  4. Yardage \$2/hd

## Cattle & Consignor Requirements

### Vaccination & Worming

- Vaccinated and boosted for IBR, BVD, BRSV, PI3, Pasteurella & Blackleg. Both rounds must be modified live.
- Dewormed a maximum of 60 days before the sale, unless Long Range is used, then 100 days prior to the sale.

### Weaning

- Purchased cattle must be owned 60 days and be 60 days bunk broke. Home raised cattle must be 60 days weaned and bunk broke.

### Nutrition

- Free choice salt and mineral supplement which contains a minimum of 1,400 ppm copper (not oxide), 26 ppm selenium, 3,000 ppm zinc, 3,000 ppm manganese and 18-25% salt with no other salt available.
- It is recommended to provide high quality, high energy rations for the first 3-5 days postweaning.
- \*Do Not Overfeed - Fleishy cattle should be avoided.

### Processing

- All cattle must polled or dehorned, smooth headed and healed.
- All bull calves must be completely castrated and healed. (Knife castration at or prior to weaning is strongly recommended.)
- All cattle must be P.I. tested negative.

### Open Heifer / Steer Guarantee

- All heifers are guaranteed to be open at the time of sale and steers are guaranteed not to be bulls or stags.

## The Charolais Influenced Feeder Calf Alliance Sale Requirements

### Type and Kind

- Must be Charolais or Charolais crossed.

### Nutrition

- Trained to eat feed from a bunk and drink water from a trough. (Do not overfeed! Fleshy calves should be avoided and are likely to be discounted.)
- Free choice salt and mineral supplement which contains a minimum of 1,400 ppm copper (not oxide), 26 ppm selenium, 3,000 ppm zinc, 3,000 ppm manganese, and 18 - 25% No other salt available.
- It is recommended to provide high quality, high energy rations first 3-5 days post-weaning.

### Health Records

- Complete, sign and submit to Blue Grass Stockyards South this sale certification form regarding the name of vaccines, lot or serial number and dates of administration.

### Processing

- All bull calves must be completely castrated and healed (knife castration at or prior to weaning is strongly recommended). Late castrated calves may lead to stags. Calves appearing to be stags at grading will sell as outs. Calves identified as stags or bulls after the sale will require reimbursement to the buyer.
- HORNS: All cattle will be dehorned, smooth headed and healed or polled. NO EXCEPTIONS!
- All cattle must be tested P.I tested negative.
- Administration of vaccine:
  1. Use the neck area for intramuscular injections
  2. Use subcutaneous injection if labeled on product which also should be given in the neck area.
  3. Follow label directions and handle vaccines properly.

### Ear Tags

- Charolais Influenced tags are required on all cattle and may be ordered from the Kentucky Beef Network.

### Commission and Fees

- Charolais Influenced Feeder Calf Alliance will collect \$4/head to support the advertising and promotion of Charolais cattle in Kentucky, this will be deducted from your check.
- The cost of tags ordered is \$2/tag and will be deducted from your check by the Charolais Influenced Feeder Calf Alliance.
- Blue Grass South will deduct the following fees from your check:
  1. Commission fee of \$20/head
  2. Beef Checkoff \$2/head
  3. Insurance
  4. Yardage \$2/hd

### ALL SALES ARE ABSOLUTE!

- Heifers are guaranteed open at time of sale and steers are guaranteed not to be bulls/stags. Seller agrees to reimburse buyer \$200.00 for pregnant heifers or bulls/stags. All claims must be properly verified by a veterinarian within four (4) months of sale.
